DOMESTIC VIOLENCE AWARNESS MONTH PROCLAMATION

In the City of Chowchilla in recognition of the important work done by survivors, domestic violence programs and victim service providers, I urge all citizens to actively participate in the scheduled activities and programs sponsored by Community Action Partnership of Madera County-Victim Services and other community organizations to work toward the elimination of intimate partner violence.

WHEREAS, in just one day, across the U.S. and its territories, nearly 75,000 victims of domestic violence sought services from domestic violence programs and shelters. That same day, more than 9,000 requests for services, including emergency shelter, housing, transportation, childcare and legal representation, could not be provided because programs lacked the resources to meet victims' needs:

WHEREAS, the impact of domestic violence is wide ranging, directly affecting individuals and society as a whole, here in this community, throughout the United States and the world, and

WHEREAS, the need for safe house continues to be rated as survivors' most urgent need; and

WHEREAS, the City of Chowchilla joins with others across California and the nation in supporting victims of domestic violence, as well as local programs, state coalitions, national organizations, and other agencies nationwide who are committed to increasing public awareness of domestic violence and sending a clear message to abusers that domestic violence is not tolerated in the City of Chowchilla;

WHEREAS, domestic violence impacts millions of people each year, but it can be prevented. Preventing domestic violence requires the collective voice and power of individuals, families, institutions, and systems – each whose adds a valuable and powerful component to transforming our communities.

NOW, THEREFORE BE IT RESOLVED, that the City Council of the City of Chowchilla does hereby proclaim October 2021 as DOMESTIC VIOLENCE AWARENESS MONTH.

RECOMMENDATION:

That City Council approve a resolution to authorize the City Administrator or designee to execute an agreement with Divcon, Inc. for the Police Department Security Fence Project and amend the City of Chowchilla Fiscal Year (FY) 2021/22 Budget.

BACKGROUND:

On August 10, 2021, City Council ratified Emergency Services Director Order #03-2021, relating to the Installation of Perimeter Fencing Around the Chowchilla Police Department as a safety concern and authorizing emergency procurement measures. As a result, the City of Chowchilla recently requested bids from qualified building contractors to construct security fence improvements at the police department. This project will include the installation of secure fencing around the police department vehicles and employee parking areas and covered parking for additional security and protection from the elements.

The did requests pursued a best value approach but also required contractors to include when they could start, construction length, anticipated material delays and a reference check.

On Friday, October 1, 2021 at 11:00 AM, the bid period was closed at which time five (5) bids were received from:

- Divcon, Inc.
- Bobo Construction, Inc.
- Davis Moreno Construction, Inc.
- D.H. Williams Construction, Inc.
- Diede Construction, Inc.

REASON FOR RECOMMENDATION:

After reviewing the bids from the October 1st, 2021 bid opening, Divcon Inc. was determined to be the lowest bidder with a base bid amount of \$1,158,926.00. Divcon's total bid, including all five add alternates, was also the lowest total bid for an amount of \$1,380,876.00.

Divcon Inc.'s proposed schedule also provides for the most expeditious completion of the work, with ten (10) calendar days to start (once given the Notice to Proceed) and sixty (60) working days to complete. Divcon stated that they do not expect the material lead times to impact their proposed 60 working day schedule if the material submittals may be reviewed and approved immediately upon project award. Divcon met the work experience requirement, and a reference check was performed based on their previous projects completed. No issues were discovered during the reference check. As a result, staff recommends that Divcon Inc. be awarded the contract for the work. Additionally, staff recommends awarding the Bid Alternate #3, Alternate #4 and Alternate #5. The total contract to be awarded to Divcon, Inc. is \$1,181,925.00.

FISCAL IMPACT:

A total of \$1,050,000 of funding for this project is currently budgeted in the FY 2021/22 City Budget and comes from the following funds:
