

City of Chowchilla Halloween Event, Trunk or Treat Registration

You may use a pop-up if you do not have adequate trunk space. All pop-ups will be placed on the grass area of the park.



- All pop-ups will be in the park area, and staff will decide the location.
- All trunks/Pop-ups must be pre-registered to participate in this event.
- All participating vehicles/pop-ups must be decorated. We encourage owners to dress up as well.
- Vehicles/Pop-ups can be decorated to advertise in good taste; if in doubt, do not use them.
- Signs/banners can be used to promote your business but must stay within the allotted space.
- No electricity is available, and quiet generators are permissible but must be turned off by the time the movie begins.
- All trunks/participants may arrive at the park beginning at 3:00 pm.
- 6th & 7th street will be closed to traffic; no unloading in this area. Only those who are using their vehicles will be allowed in this area. Kings street is the only close area to unload your items. No Parking on Robertson Blvd., as it is a hazard during the event for pedestrians. Participants will have to find parking on the open side streets.
- All vehicles/Pop-Up Tents must be decorated by 5:00 pm.
- Trunks/Participants arriving after 5:00 pm will not be able to participate.
- The event will begin at 5:30 pm. Trunk or Treat 5:30 pm - 6:30 pm, Costume Contest 6:00 pm, Movie begins at 6:45 pm - 8:25 pm.
- All vehicles must stay in place until the Trunk or Treat activity is over. You do not have to stay through the movie; however, you must be quiet during the movie when packing up.
- This event is held at a new venue this year, so it is difficult to predict the number of guests you will have. We suggest planning for 1,000 children. There is an age limit on the participants of 2 to 12 years of age. We require the children to be present to receive the candy.
- The deadline for entry is 4:00 pm on Friday, October 21st.
- We encourage online registration; payment with a credit/debit card is required to complete registration.
- If you are unable to register online, you may come to City Hall, and we will register you. Payment is due at the time of registration.
