SUMMARY EXPLANATION OF FEES

The fees are broken into sections by the primary department. However, fees are charged in accordance with the entire fee schedule, an example would be Community Development charging from the Public Works section.

Please note that only the City Council can waive fees therefore staff is required to charge all the fees listed. The City Administrator can waive fees after receiving a Dispute Form from the public up to \$5,000, all waivers are submitted to City Council quarterly as a report.

Other fees may be passed on other resolutions or through Proposition 218 hearings. Some fees are set by Federal and State Laws.

All fees are non-refundable unless otherwise stated.

MASTER PLAN process requires Director of Community and Economic Development Approval

Additional Fees will be charged at the discretion of the Director of Community and Economic Development.
- III. Unusual or Unforeseen projects shall be charged fees based on a per hour basis for plan review, consultation, and inspection at \$112.00 per hour.
- IV. The Director of Community and Economic Development shall have the authority to increase the fee based upon staff’s anticipated time in any individual case, not to exceed the actual cost to process and inspect the permit.
- V. The amount of the fees shall be adjusted annually, at the beginning of each calendar year, to account for inflation by using the Consumer Price Index (CPI) for the Western Region. In no event shall the fees in any year be less than in the preceding year.

Additional Fees will be charged at the discretion of the Director of Community and Economic Development
- II. Unusual or Unforeseen projects shall be charged fees based on a per hour basis for plan review, consultation, and inspection at \$100.00 per hour.
- III. The Director of Community and Economic Development shall have the authority to increase the fee based upon staff's anticipated time in any individual case, not to exceed the actual cost to process and inspect the permit.
- IV. Add \$15.00 for City the City of Chowchilla General Plan Update and Computer Software Infrastructure Recovery Fee.
- V. The amount of the fees shall be adjusted annually, at the beginning of each calendar year, to account for inflation by using the Consumer Price Index (CPI) for the Western Region. In no event shall the fees in any year be less than in the preceding year.
